# A MESSAGE FROM OUR CEO

#### Dear Friends,

Thank you for supporting Rosemary's Babies Company as we, in year four, work to build our four-tress. In 2020, the pandemic forced Rosemary's Babies Co. to expand our scope of services, commit to more direct needs of adolescent families, as well as ensure families felt safe and supported from afar. Our year at times was trying but RBC remained resilient and so did our families; completing schoolwork, spending quality time with their babies, and obtaining jobs. With the support of our community partners, volunteers, and many contributors we successfully served 471 families, distributed more than \$50,000 in funds and resources, distributed 1,400 pounds of food to families, and provided 56 Christmases.

Pre-pandemic our organization provided virtual services 24/7 through social media; fortunately, this was an advantage and reduced the severity of interference when responding to families in crisis. The additional funds we received for COVID response allowed our organization to hire and maintain staff, distribute PPE, as well as provide resources to families; our program participation doubled during the crisis. We would like to thank the Greater Cincinnati Foundation, Hamilton County Cares, United Way of Greater Cincinnati, Rockefeller Foundation, and Delta Foundation for their support.

Rosemary's Babies would like to acknowledge Spark Philanthropy, who supported our organization during this crisis. Karen Harshaw, the CEO, helped RBC to develop a fundraising, marketing, and communication plan that aligned with our new 3-year strategic plan. With her support, we were able to leverage our funding, diversify our donors, and focus on intentional partnerships that would contribute to increasing organizational capacity. As an organization, we increased our funding by more than 200%.

## **A BRIEF HISTORY**

Rosemary's Babies Company was birthed by founder Rosemary Oglesby-Henry. She used her life experiences as a teen parent, education in Leadership, and personal trauma to create a resource for teen parents. In 2013, after realizing that in the years it took her child to grow up, teen parents were still facing many of the obstacles she faced when she was a young parent in their position. She knew a solution to this problem would be to provide resources, education, and life skills to teen parents first-hand as she had done with family and friends. With the goal being to provide help in navigating the difficulties of teen parenthood from a generational perspective, she began building on this dream deferred. Five years after conception, Rosemary's Babies Company is growing. In the first years of its existence, it has aided hundreds of teens through hotline services, emergency care, and programs aimed at helping teen parents build their legacy. Rosemary's Babies Co. exists to model a path to success for teen parenthood.

# RBC served **471 families** in 2020 of these families **34 parents enrolled in the**Leadership & Legacy Program




The pandemic posed challenges for our babies and our organization. Our program participation doubled. 30% of the year our organization provided limited in-person support. 30% of families requesting services were homeless.



## WHAT RBC MEASURES

- 100% of parents/caregivers increased their ability to support their child's development
- 100% of parents had healthy
- 100% enrolled in school attended regularly, graduated, or received GED pregnancies and childbirths
- 99.97% reported no intended repeat pregnancies
- 87% of parents reported being in good health
- 50% of program participants had access to mental healthcare
- 0% infant mortalities


# FINANCIAL REPORT & SUMMARY


Rosemary's Babies Company (RBC) shows a consistent increase in revenue from 2016-2020.

Since RBC's 2016 launch, the organization has shown a steady increase in revenue.


In 2020, revenue increased by 200%.

Based on the 2020, reported revenue 58% of all revenue are grants, 9% is funding from United Way of Greater Cincinnati, and 33% of all other contributions are direct campaigns organized by the non-profit.


