BACKGROUND

WHO WE ARE

Established in 2016, Rosemary’s Babies Company (RBC) provides support for parenting youth, ages 13-19, and their families. By providing family support to three generations - the teen parent, the grandparents, and the child – RBC can change the trajectory for the entire family. **Rosemary’s Babies Company mission is to help teen parents master the concepts of self-leadership to break the cycle of poverty and become a productive member of their community.**

WHO WE SERVE

Currently, RBC serves diverse families of all socio-economic backgrounds, moms and dads, intentionally targeting the most at-risk populations. Of teen parent families contacting our office:

- **35% are homeless** or live with a person who is not their primary guardian.
- 95% or more fall below the 200% poverty level.
- 95% or more are minorities.
- 20% are in foster care.
- More than 50% are experiencing food insecurity or live in a food desert.

Since 2016, Rosemary's Babies Company has served 400 Families in Greater Cincinnati.

OUR UNIQUE EXPERTISE AND APPROACH

RBC uses evidence-based interventions, leadership education, and mentoring to teach teen parents (moms and dads) life skills, problem-solving and resilience during their simultaneous transition from child to parent, and child to adult. RBC assists families in removing barriers, long-term and short-term, so these adolescents can begin work on their life-plan for themselves and their babies. 86% of team members and board members were teen parents themselves.

RBC focuses on the core areas of mental and physical health, including healthy behaviors, education, and money management. Rosemary Babies partners with more than 100 agencies to support our families, including UWGC (Funding/Resources), UC Health (Funding/Health), Tri-health (Labor/Delivery), 4C for Children (Childcare), ODJFS (PRC Funds/Childcare Vouchers), and Children’s Law Department (Legal).

PROGRAM OUTCOMES

- **100% of participants did not have a repeat pregnancy.**
- 100% of pregnant participants received adequate prenatal care.
- 100% of program participants received and/or had access to mental healthcare.
- 100% of program participants are introduced to STEM principals.
- 83% or program participants reported having good and/or excellent health by teen parent survey.
- 62% of program participants reported improving healthy behaviors.

EXECUTIVE SUMMARY

THE NEED

Thirty-five percent of teen parents in Greater Cincinnati are homeless. There is currently NO supportive housing options and/or continuation of care programming that provides a skills-building foundation to help young parents develop self-sufficiency so that they may be successful engaged parents and productive members of their community. These conditions drive the cycle of generational pregnancy, poverty, homelessness, and maltreatment of their children.

- The 2016 teen birth rate in Cincinnati was estimated to be 43.3 births per 1,000 women between 15-19 years old.
- There are more than 3,000 teen births yearly in Hamilton County.
- There are 12,000+ births to teen parents yearly in Ohio, Kentucky & Indiana.
- There is a higher occurrence of pregnancy among homeless youth, 13-15-year-old. They are 14 times more like to have repeat/dual pregnancies.

Supportive Housing is a highly integrated system of living arrangements and professional case management services that provides pregnant and/or parenting teens **1. a safe place to live, 2. 24-hour access to caring adults, and 3. connections to community resources that provide share responsibility plans**. This system helps young parents develop necessary skills and secure resources needed to maintain housing throughout adulthood. Supportive housing programs can be more effective when young parents shape and direct their future in partnership with case managers and other key staff.

COST SAVINGS ANALYSIS

Reduce dual pregnancies by program participants by 100% by 2023

- **A reduction in dual pregnancies of 100 teen parents is a cost savings of \$1.6M to the tri-state area.** 50% of teens who have a baby are far more likely to have a second child before adult age (20). Investing in transitional housing and skills-building programming for teen parents would mean fewer teen parents starting their life in poverty and a **reduction in mothers who are on welfare or receiving medical costs for labor & delivery**.

Increase number of teen parents graduating from high school by 25% by 2023

- **A reduction in high school dropouts adds a tax revenue of \$260K per teen to the tri-state area. Resulting in a life tax revenue of \$26M, per 100 teens served.** Teen parents that complete high school can secure better paying jobs and are less likely to have subsequent children which leads to a need for welfare benefits.

THE GOAL

A managed site for teen parent families that will provide emergency and transitional housing, continuation of care, parenting classes, workforce development, financial literacy, life skills, case management and address any/all needs related to teen parents in Greater Cincinnati. Using a holistic approach, this *safe space* will provide housing for up to 14 teen parent families.

THE DEMOGRAPHIC SERVED


This property will serve teen parents ages 13-19 years of age of all ethnicities, sexual orientations, socioeconomics, and religious backgrounds. Emergency housing/transitional housing will serve teen parents 16-19 years who are in foster care, homeless, emancipated, or who have been displaced by unforeseen circumstances.

OUR PROJECT REQUEST

Rosemary's Babies Company is requesting support in the purchasing and/development of a commercial/multi-use property in North Avondale located at 3864 Reading Road Cincinnati Ohio 45229. This property is 6,400 sq. feet, 7 bedrooms and 4 bathrooms with backyard, full kitchen, and dining area.

THE NAME



Holloway House is named for Rosa Lee Webster-Figgs, grandmother of founder Rosemary Oglesby-Henry. Rosa Lee was a teen mother at 15. In 1942, she left her home in Tennessee for Cincinnati to build a better life for her and her baby. Because she was illiterate, she worked as a maid for most of her life until she received her high school diploma at age 34; she believed education was the one thing a person could not take away from her. Rosa Lee Webster-Figgs, known by the community as, “Mother Figgs” or “Grandma Rose” raised seven (7) children and a host of others in a three-bedroom house on Holloway in Evanston refusing any assistance from the government. For more than 70 years she cared for her

community, fought against injustice and opened her house to children. Her legacy and name live on through her granddaughter, Rose, whose organization does the same for teen parents. Holloway House is named in memoriam of this woman who inspired our core beliefs: truth, education and integrity. Ms. Rosa Lee Webster- Figgs was called to Heaven on June 18, 2020.

APPENDIX

RBC & AVONDALE QOL MOVEMENT

Holloway House & Resource Center will be an expansion of the programming that RBC has successfully managed in the community since 2016. Of RBC's 400 families, **30% of teen parents live in Avondale, 60% of program participants were children of teen parents, 100% of these families live in single parent households whose income is below \$25,000.**

Based on the Avondale Quality of Life Plan more than 2700 youth are at risk of becoming teen parents, based on the ACES (Adverse Childhood Experiences) assessment and historical evidence that shows a direct correlation between socioeconomic and teen pregnancy including poverty, lack of education, homelessness, and lack of positive mentorship. **Holloway House will be a safe hub for families serving three generations: teen parent, grandparents, and child(ren).**



SAFETY

“Despite the multiple resources for children to engage, there is notable concern over youth with nothing to do.” QOL Plan.

- RBC has partnered with R.E.A.L Truth Inc. who will implement programming for youth and their families. This program's focus is safety, self-defense, laws and regulations, and lifestyle changes as it relates to violence.
- RBC is working with the public defender's office, Cincinnati Police, social service agencies and community leaders to educate the community, provide support for families, and mediate disputes within families to alleviate ejections of youth/youth parents from their homes. **A.T.E.** (Alternatives to Ejection) will reduce homelessness and impact mortality of youth and babies by securing a safe space for children to live.

SHARING SUCCESS

Rosemary's Babies Company focuses on intervention, education, and prevention. RBC's advocacy and collaboration efforts have helped our organization to secure partnerships with **employers who will give opportunities to young families** like The Country Meat Co., Queen City Healthcare, and Cincinnati Works.

RBC program involves financial education, workforce development, training and parenting education, as well as recreational activities for the entire family. Through collaborative efforts RBC will get **young parents employed, improve the health of teen parents and their babies, remove social barriers that keep teen parents from quality healthcare** that keep them from maintaining employment, and worse infant mortality or death.

RBC **partnerships build a network of support that is accessible to families** that includes daycare, education, and home visitations with children up to age 3. These efforts have helped to **contribute to completion of high school/GED, reduction in dual pregnancies, healthier pregnancies due to reduced social barriers and healthier behaviors, and reduction of social services calls related to neglect and child abuse.** Community Partnerships that align with the Quality of Life Movement includes: Hamilton County Health Department, Cincinnati Children's Hospital's Every Child Succeeds, Healthcare Access Now, Cradle Cincinnati Policy Committee, Hamilton County Public Defender's Office, Cincinnati Black Doula Network, Evenflo Breastfeeding; as well as local high schools and charter schools including Woodward High School and Keeping Teen Parents in School (Dohn).



LIVE HEALTHIER & HAPPIER

This space will transform Avondale in a unique way providing an exclusive program and space that will bring families together; as well as support the notion that Avondale is a safe place to work, live and play. The organizations accessibility will help to encourage better health as we are surrounded by healthcare agencies which we partner, parks, community centers, and churches. **100% of teen parents and their parents report following connecting with our organization the family is healthier and happier.**

PROJECT CONTRACTORS

Rosemary's Babies Company has secured MBE contractors, architects, and landscapers for this project. RBC has secured a WBE & MBE designer and realtor to support with the purchase and design elements of the 6,400 square foot space that currently has 7 Bedrooms, 5 Bathrooms.





Rosemary's Babies Company is a teen parent and family support organization that has served 400 teen parent families in the tri-state area since 2016. We are seeking to purchase in partnership with The City of Cincinnati, The Port Authority, Hamilton County Land Bank and North Avondale Community to renovate The Rubel House, which has been estimated to have been unoccupied since 2015. This commercial/multi-use property is 6400 sq ft, with 17 rooms including the potential for 7 bedrooms & 4+ bathrooms.

The following inspections are necessary:

- Lead inspection
- Home inspection including termite
- Mold remediation & removal
- Structural engineer (will seek information from previous contractor familiar with this project)

The property will need the following renovations & improvements:

- Kitchen remodel including commercial appliances
- Updated electrical
- Boiler & water heater replacements
- Glass & window replacements
- Concrete in rear yard
- Doors, finishes and fixtures
- Paint walls & room remodels

RBC intends to:

- Contact SSRG for estimated cost
- Historical preservation society to ensure historical elements are maintained with the property
- Re-purpose rather than replace floors
- Re-purpose original fireplace
- Re-purpose molding

IMPROVEMENTS

In July 2018 – August 2019 SSRG Advantage Group Architect / Engineers were contracted to perform restoration & stabilization to the property.

The SSRG team led the restoration of the stunning front porch. This stately feature includes an impressive rounded corner, but the entire structure had fallen into grave disrepair. SSRG rebuilt the porch with a standing seam metal roof. This required saving the original corbels and recreating the historic timbers. One particularly unique element of the project was the rounded corner. The original structure had used one large timber curved into its radial arc, as opposed to connecting multiple beams together. To match the original quality of this feature, the SSRG team built a steam chamber and steamed a large timber to bend it slowly and carefully into the radius needed.

Other scope of the project included rebuilding chimneys, slate roof repairs, and rebuilding several collapsed floors.

Rosemary has achieved all her educational and career success because of her resilience and fortitude to change the trajectory of her life and her family since becoming a teen parent at the age of 16. Graduating from Withrow High school as a teen parent, she faced the stigma and challenges of a teen parent firsthand, but she also had the determination that single parents need to rise above adversity. Rosemary's personal commitment to her children, strong faith in God, social support and self-motivation kept her focused on her goals.

Despite the obstacles, she successfully managed a home, raised two children with her husband and long-time sweetheart of 23 years and maintained a 17-year career with the United States Postal Service. Throughout her journey to break the cycle of generational pregnancy and poverty within her family, she felt an immense desire to give back.

To be successful in any capacity, Rosemary believes an accredited degree is vital. Ms. Oglesby-Henry, held to her educational goals for more than 15 years to obtain a Master of Science in Organizational Leadership, Bachelor of Arts degree in Liberal Studies, a Business Administration degree and an Associate of Art in Human Resources; RBC was conceptualized during her Master's program at Mount St. Joseph University in 2013.

Rosemary established RBC as her second act, in an effort to educate the community, advocate for rights that render teen parents helpless, and support young parents who feel that having a child during early adolescence means an inescapable life of poverty. The Cincinnati based organization, which serves 200 families per year, works to end generational pregnancy and poverty by supporting families, educating communities, and advocating for policy/law changes that are biased and render teen parent families helpless. Rosemary's Babies is recognized as a best in class resource for teen parents and families.

Rosemary also serves on my Cradle Cincinnati Policy committee that works to reduce infant mortality and remove barriers for pregnant mothers, with a focus on women of color. With the help of Rosemary Oglesby-Henry, these efforts have resulted in the highest reduction in Black infant mortality in Hamilton County this past year.

Rosemary's Babies Company is the location we host our policy committee meetings with city leaders and community organizations, and they have ensured us we can continue our relationship in their new facility which is desperately needed.

Unfortunately, teen parents are not considered when we review the demands for transitional and affordable housing in our city. Rosemary's Babies Company has been the voice in these conversations to address this need, at present a parenting teen has no place to reside. Rosemary's Babies Company is doing the work and their results shows and I support their unique efforts to create a safe space that includes housing for parents.


